In late September, the Call Committee identified a primary candidate that they felt would be a good fit for Pastor of our Church. After reviewing the candidate's credentials and holding interviews with the candidate, the Council agreed to move toward. With final approval from the Church Council, the Congregation and the Bishop, we offered Pastor Nathaniel Bendorf the position of Pastor of Grace. Pastor Bendorf graciously accepted the position. We welcomed Pastor Bendorf and his family on the first Sunday in Advent. We are all excited for what the future holds with Pastor Nate!

The Pumpkin Patch had a very successful and record-breaking year. While the pumpkins arrived later than expected, and we had a very short time to sell the pumpkins, we made a considerable profit. Many thanks to all of our volunteers who made this event successful.

Since we were not able to hold our Annual Thanksgiving dinner or collect food items for holiday baskets, we provided gift cards to needy families for local supermarkets.

The Social Ministry, through your generous contributions and donations, were able to help many needy families and children experience a special Christmas.

After this very long year, we celebrated the birth of Christ with two, special candle light Christmas services on Christmas Eve.

We were saddened to lose some long time and faithful Church members in 2020. J.R. Anderson, Pat Beck, George Cunard, Mike Eland, Larry Fisher, Orville Fulkerson, Bill Kohlman and Ken Wenzel are now soaring with the angels. Please continue to offer support, help and prayers for their families.

Adult Education

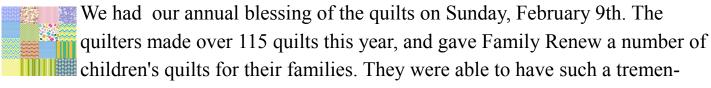

Before we closed the church in March, there were home visits to members, blood pressure checks after church services, and attendance at the monthly Faith Community Nurses of Volusia County meetings which allowed us to share and receive resources to benefit members of Grace. Since Covid became a pandemic, we have had zoom meetings with the Faith Community Nurses to share the latest information on Covid-19, continual calls to church members to help with health questions and resources for those in need. continued with monthly articles for the church newsletter when it was published, and collected and delivered many unused medications to the Bunnell Free Clinic which is a great benefit to those in need. Throughout the summer, there were zoom meetings to establish guidelines for the church and Noah's Ark to re-open, and these guidelines have allowed us to open both without incident. As this pandemic continues, I hope everyone is taking the appropriate precautions and following the CDC guidelines. This has taken much longer to conquer than we had originally planned, but conquer it we will, as we look forward to a time when we can all get back together again.

Noah's Ark Pre School Annual Report 2020

Noah's Ark was profoundly affected by Covid-19 in 2020. The year started out with 5 classrooms, with 2 teachers per classroom, averaging 15-20 children per classroom per day. The hours were from 7:00am to 6:00pm, and the parents brought them into the school, signed them in and dropped them off at their classroom door. January was testing and reading time, and at the end of January, we got the best news, ever.

Our thirty one VPK students from the previous year had tested so well in kindergarten, we were given 100% rating for the first time in the history of the VPK program at Grace. February was Valentine's and more reading. Then came the Ides of March, and Covid-19. We closed down on March 14th at the request of the ELCA Synod and in conjunction with advice from the Dept. of Education and Dept. of Health in the State of Florida. Every parent was personally notified of our decision. We stayed closed until June 1st, when we re-opened under very different circumstances. We had strict adherence to all of the Covid rules and regulations put out by the CDC and the Dept. of Education. ONLY children and staff are allowed in the building, and then only after temperatures are checked and hand sanitizer used. The classrooms were limited in size to 11 children each room with one teacher per class. Hand sanitizers in every room, disinfectant sprayed every night, and special cleaning product for tables and chairs. Masks were worn by the adults. All of this has continued throughout the rest of the calendar year. The children arrive between 7:30 am and 9:00am and must be picked up by 5:00pm. Also we have operated at half capacity since June. The children know the routine at drop off and pick up and follow it carefully so they don't get "rona"

We have been fortunate and careful. Only 1 child has had COVID and 2 other children and 1 teacher have had exposure to Covid. Unlike a number of other schools, we have not had to close a single day, and only twice have we had to deep clean a room. Yes, we had to cancel our concerts, reschedule graduation, redo many of our activities, BUT it all got done, and we are probably the better for it. Our teachers have been incredibly loyal to us, and we have to them. They have not missed one paycheck throughout the year, even when we were closed. It has truly been a difficult, inventive, and rewarding year. WE WANT TO THANK EVERYONE OF YOU FOR YOUR SUPPORT AND PRAYERS THROUGHOUT 2020.

Property Committee Annual Report 2020

The property committee had a very quiet year in comparison to 2019. Of course, Covid 19 affected what we did and didn't need to do this year. The church and school were closed from March 14 to June 1st. The school reopened on a limited basis on June 1st with only children and staff allowed in the building. The church re-opened August 29th with Covid limitations.

The things we had to do began with the replacement of the kitchen water heater, located in the maintenance shop, and as in most "things" that breakdown, it isn't a simple matter to just replace the item. In this case, the piping leading to it had been "rigged" and wasn't up to code, so besides the new water heater we had to run new piping for it, to bring us in compliance. We also finally received the backorder on the lights that were in the ceiling over the altar and the cross so our lighting project got finished in February. We are totally "LED" throughout the complex. We waited to convert the driveway lights to LED until one of them burned out, and that happened in March, so we "fixed" them as well.

Our air conditioning systems held up quite well this year, with the exception of the condenser coil on the main unit in the sanctuary, and replacing our oldest AC unit in the VPK classroom. It was going on it's 16th year, and just quit working, so it had to be replaced.

The Church Council decided to improve on the covering for the office window for hurricane protection, so we ordered a custom screen which can be installed in less than 30 minutes with 2 people. The old plywood boards have been put to rest. The screen arrived and was installed last week. It is a wonderful improvement from the plywood boards.

The rest of the year was spent keeping the grounds mowed and trimmed, pressure washing where needed, and maintaining our curb appeal. Hopefully 2021 will include a refurbished front sign, and an upgraded entrance to the parking lot. We will keep on keeping on throughout the year, remembering this is an older building exposed to a lot of salt air, which requires us to be vigilant in our maintenance of our property.

Finance Committee Annual Report 2020

The Finance committee had a very challenging year, thanks to Covid 19. When we put together the 2020 budget, we had high expectations, and little did we dream they would be tossed out the window in less than 3 months. The greatest gift we had and received was the support from ALL OF YOU. Your continued support of Grace was outstanding, and your faithfulness in sending in your pledges enabled us to pay our bills in a timely manner We increased our envelope giving by 1.7% and your generosity of giving allowed us to cover 74% of our expenses with just "envelope" giving. The balance of our income, \$68,223.08 ,came from our investment income, our pre-school, mausoleum, parking lot lease, gift shop, and user fees. Our total income exceeded our expenditures by over \$30,000.00. We also received \$1125.00 given in memory of our dearly departed, \$3,246.25 was given for quarterstone along with \$190.00 in quarter rolls, and we received over \$1,000.00 for our social ministry efforts.

Our expenses totaled \$202,617.72 which was \$44,858.28 below budget. Our electrical and water bills continue to decrease bearing the fruits of our major capital expenditures in 2019. We have cut the electricity in half from our 2018/2019 expenditures, and we have reduced the water consumption by 35%. We obviously reduced a lot of our operational budget because Covid didn't allow us to get together for fellowship, eating, quilting, and 6 months of no church services. Services have resumed by following Covid restrictions and we are averaging 70-75 people in attendance every Sunday.

Our investment banker is Debra Stephens, from Raymond James. Debra continues providing us with an excellent return on our investments. We have continually chosen to go with stocks that will provide us with a monthly income to augment our donations, and this year was no exception. We lost a lot of value as did everyone else when Covid hit in March, but we have watched the stock market rebound and the value of our stocks is continually improving. As of the end of the year we had regained almost 75% of what we had lost in value. Based on Deb's advice, we will continue to ride it out, and grow in value without making any major changes.

Thank you to our counters Sandy Hostettler, Joyce Northridge and Frank & Cathy Quel for another year of "perfect" work. A special thank you to Sandy Hostettler for a year of keeping, balancing, and reporting all of the income from our members. The best sound of all is, "We balance" at the end of every month.
